

ChatGPT | Open Al

- The most advanced AI language model available today is ChatGPT
- What is ChatGPT?
- ChatGPT is an AI language model developed by OpenAI that can understand and generate human-like language
- Has been trained on vast amounts of text data and can generate responses to a wide range of prompts



How can ChatGPT be used in legal practice?

- Summaries / chronologies / tasks
- Witness statements

 Lawyer etc (writing speeches)

Bias in the training data and outputs


Confidentiality and security of client information




What is OpenAl Open Playground?

Seminar applies to both manual and automatic dictation transcription

Pros of manual transcription: better accuracy and team camaraderie; Cons: higher cost and less flexibility

Dictation still works for litigators and commercial drafters.

WHY HAS DICTATION FALLEN AWAY? (BTW, IT'S NOT A GOOD **REASON TO** NOT TAKE IT UP!)

- The shift away from secretaries in law firms began in the late 1990s.
- Before 2000, every lawyer had their own secretary, who primarily focused on document production.
- The microeconomic theory and organizational behavior of law firms revolved around lawyers having secretaries.

WHY HAS DICTATION FALLEN AWAY? (BTW, IT'S NOT A GOOD **REASON TO NOT** TAKE IT UP!)

- The average young lawyer today does not fully appreciate the role that secretaries played in the past.
- Lawyers spent much of their time dictating documents into their dictaphones, which were then transcribed by secretaries.
- The costs of secretaries and overheads easily took up one third of the costs of production for law firms.

Decline of touch typing



Touch typing was taught in high schools as a necessary skill for secretarial work.



The shift towards personal computing and typed assignments in universities led to the disappearance of touch typing courses in high schools.



People began to learn how to type at a younger age and in an informal way through "hunt and peck" typing.

Decline of touch typing



The decline in touch typing skills among secretaries and junior lawyers led to a decrease in the speed and quantity of document production.



Junior lawyers who spent most of their time typing were less verbally capable and less able to think on their feet.



The shift towards "hunt and peck" typing had both short-term benefits and long-term downsides.



Typing and editing as you go can limit the ability to see the big picture and patterns, while dictating can allow for a more forward-thinking approach.

Voice recognition software has improved significantly since 2013-2014, becoming more intuitive and requiring less training.

How to dictate

- Consider software options, including
 Dragon NaturallySpeaking, Google
 Docs, and online services like Rev
- Measure software options against human transcriptionists
- Hardware options include headset, handset, dictaphone, and tailor-made software on smartphones


How to dictate

- Consider employing a human transcriptionist for the first few months if unsure of software mechanics
- Have a mindset that dictation is better and practice enthusiastically
- Plan what you're going to say before speaking, using tools like mind maps




How to dictate

- Dive straight into dictation as a primary writing process, rather than gradually shifting
- Use a third party to transcribe if possible, with a standard instruction process and sheet
- Deliberately avoid saying "umm" and "aah" to avoid disrupting software or distracting a human transcriptionist.




Best way to start dictating

- Have a positive mindset and believe in the benefits of dictation.
- Practice regularly and with a method.
- Plan what you're going to say before you start dictating, using tools like mind maps.


The physical space

The physical space

- Dictation offers the advantage of physical freedom, allowing lawyers to stand up, walk around, and be more active.
- There may be a concern of people listening in and overhearing poorquality work, but they eventually become bored and tune out.
- Open plan offices can be a roadblock to dictation, but it is important to push through and accept being overheard.


The physical space *for* dictating

- Proper dictation requires speaking and projecting your voice; speaking quietly will not work.
- The risk of "tech neck" is also reduced by not sitting at a computer all day.
- Dictation can be done in any physical location that allows for speaking aloud, as long as there is minimal background noise.


